**on cooperation in the field of Standardization**

In order to implement the Memorandum of Understanding signed for cooperation in the field of standardization between the Slovak Office of Standards, Metrology and Testing (UNMS SR) and the State Administration for Market Regulation (National Standardization Administration) of the People's Republic of China (SAMR/SAC) (herein after referred to as "the Parties"), for effective exchange of information,

the Parties have reached the following understanding on the Cooperation Plan during the years 2024 - 2028 and agreed as the following:

Deputy Director General of Standards Innovative Management Department will be the contact point in SAMR/SAC and the Director of Standardization Department/ Director of Testing and European Affairs Department will be the contact point in UNMS SR for exchange of information on the above identified activities and on other areas as mutually agreed upon. All the information under the Cooperation Plan shall be mainly provided in English language.

This Cooperation Plan may be amended or supplemented at any time by written consent of both the Parties. The Cooperation Plan will remain valid till the end of 2028.
