Artesanía y otros productos de origen animal

11/09/2022

Establece medidas sanitarias para la importación a Chile de artesanías y otros productos que indica.

La propuesta de medida establece exigencias sanitarias para el ingreso a Chile de artesanías y otros productos de origen animal por courier o importación comercial:

1. Los siguientes elementos: cráneos, cuernos, astas, huesos, dientes, pezuñas, cascos, garras, uñas, escamas, y los ítems confeccionados con uno o más de los elementos mencionados anteriormente o confeccionados con cuero, plumas, pelos, crines y cerdas, como: artículos de bisutería o joyería, artículos de decoración, artesanías, instrumentos musicales y vestimentas; podrán ingresar a Chile sin presentar certificado sanitario y solo si a la inspección física cumplen las siguientes condiciones:—Deben encontrarse secos y limpios;—No deben presentar vestigios de sangre, carne, piel, tendones, ligamentos, ni restos de cualquier tipo de materia orgánica animal o vegetal (fecas, tierra, etc.);—No deben presentar mal olor asociado a un proceso de descomposición;

2. En el caso de los mates de pezuña, además de cumplir lo señalado en el punto anterior, deben provenir de países reconocidos libres de fiebre aftosa (con o sin vacunación) por la Organización Mundial de Sanidad Animal (OMSA);

3. Los productos mencionados que correspondan a especímenes de especies protegidas por CITES, deben dar cumplimiento a las regulaciones específicas, cuando corresponda. No obstante lo anterior, los aspectos de salud animal o sanidad vegetal prevalecerán sobre la Ley CITES, debiendo ser aplicadas las medidas sanitarias que correspondan.

Trading partners are advised that following the outcome of the 2022 Australian Federal Election there have been some changes to the structure and names of Australian Government departments. From 1 July 2022, the former Department of Agriculture, Water and the Environment (DAWE) has been renamed to the Department of Agriculture, Fisheries and Forestry (DAFF). The only change is the name of the department and DAFF remains the Australian Government competent authority responsible for the inspection and certification, where applicable, of Australian agriculture, horticulture, fisheries, food and forestry product exports and imports. This notification is in addition to G/SPS/N/AUS/540 regarding changes to horticulture and grain products export certification to reflect the department's name change. As provided for in the abovementioned notification, updated certificates will be released during July 2022. Proposal to amend Schedule 20 of the revised Australia New Zealand Food Standards Code (12 July 2022).

This Proposal seeks to amend the Australia New Zealand Food Standards Code to align the following maximum residue limits (MRLs) for various agricultural and veterinary chemicals so that they are consistent with other national regulations relating to the safe and effective use of agricultural and veterinary chemicals:—Bupirimate, Captan, Emamectin, Fluopyram, Myclobutanil, Tebuconazole and Tetraniliprole in specified plant commodities.

Commission Implementing Regulation (EU) 2022/1219 of 14 July 2022 amending Annex III to Implementing Regulation (EU) 2020/2235 as regards model certificates for the entry into and transit through the Union of consignments of certain composite products (Text with EEA relevance).

The Regulation aligns the treatments required for entry into and transit through the Union of dairy products contained in certain composite products and clarifies some other requirements for the entry into and transit through the Union of those products in the relevant model certificates.

Import suspension of poultry meat and egg products from the Jefferson County in Washington in the United States of America.

In order to prevent the introduction of High Pathogenicity Avian Influenza (HPAI) virus into Japan, MAFF has suspended the import of poultry meat and egg products from the Jefferson County in Washington in the United States of America, including those shipped through third countries, since 11 July 2022, based on Articles 37 and 44 of the "Act on Domestic Animal Infectious Disease Control" and "Animal Health Requirements for the poultry meat etc. to be exported to Japan from the United States".
