Import Health Standard: Personal Consignments of Products for Human Consumption and Personal Effects (Draft) G/SPS/N/NZL/651 The Import Health Standard manages the biosecurity risk of personal consignments of products human consumption and personal effects across all import pathways (accompanied and unaccompanied, air, sea, mail). The Standard manages personal consignments of fresh produce (fruit vegetables), stored plant products, and personal effects (bags, clothing, tents, shoes, sports equipment, furnishings sent to New Zealand). Personal consignments of products for human consumption will be defined by an overall total combined weight of 40kg, and individual plant product limit of 2kg. All personal consignments will be required to be free from regulated pests and biosecurity contamination, and personal effects will need to be "cleaned" prior to arrival.

The DLD order on temporary suspension of importation of live poultry and poultry carcasses from France to prevent the spread of Highly Pathogenic Avian Influenza (Serotype H5N8) G/SPS/N/THA/420 According to the announcement of the Government Gazette dated 27 April 2021, the suspension for importation of live poultry and poultry carcasses in Gironde, Lot-et-Garonne and Gers departments of France has expired on 26 July 2021. However, the OIE has reported a continued outbreak of Highly Pathogenic Avian Influenza (HPAI) in Gironde, Lot-et-Garonne and Gers departments of France. Therefore, it is necessary for Thailand to prevent the entry of Highly Pathogenic Avian Influenza (HPAI) disease into the country. By the virtue of Animal Epidemics Act B.E. 2558 (2015), the importation of live poultry and poultry carcasses from France is temporarily suspended for a period of 90 days notified since 27 July 2021 onwards in the Thai Royal Gazette (9 July 2021).

The DLD order on temporary suspension of importation of bovine and buffalo and their products under Animal Epidemics Act B.E. 2558 (2015) G/SPS/N/THA/421 According to the announcement of the Government Gazette dated 28 April 2021, the suspension for importation of lumpy skin disease in Myanmar has expired on 27 July 2021. However, Myanmar has not been selfdeclaration for the recovery of country freedom from lumpy skin disease according to the OIE report. Therefore, it is necessary for Thailand to prevent the entry of lumpy skin disease into the country. By the virtue of Animal Epidemics Act B.E. 2558 (2015), the importation of bovine and buffalo and their products under Animal Epidemics Act B.E. 2558 (2015) in Myanmar is temporarily suspended for a period of 90 days notified since 28 July 2021 onward in the Thai Royal Gazette (9 July 2021).
