The Order, signed on 23 November 2022 bans the importation of domestic and wild birds and their products, including poultry meat, day-old chick, eggs and semen. It also immediately suspends the processing, evaluation of the application and issuance of SPS import clearance for the said commodities. All shipments from the mentioned areas of the United States of America that are IN TRANSIT/LOADED/ACCEPTED UNTO PORT before the official communication of this Order to the American authorities shall be allowed provided that the products were slaughtered/produced on or before 4 August 2022. Shipments which have not complied with the conditions set forth in Item 3 shall be dealt with as per DA AO 9 S. 2010 Section VII.D.

Thailand *Live poultry and poultry carcasses (HS Code(s): 0105, 0207, 0407, 0408)*

The DLD order on temporary suspension of importation of live poultry and poultry carcasses from Chinese Taipei to prevent the spread of Highly Pathogenic Avian Influenza (Subtype H5N2).

According to the announcement of the Government Gazette dated 15 August 2022, the suspension for importation of live poultry and poultry carcasses from Chinese Taipei since 15 August 2022 has expired on 12 November 2022. However, the OIE has reported a continued outbreak of Highly Pathogenic Avian Influenza (HPAI) (Subtype H5N2) in the area of Chinese Taipei. Therefore, it is necessary for Thailand to prevent the entry of disease into the country. By the virtue of Animal Epidemics Act B.E. 2558 (2015), the importation of live poultry and poultry carcasses from Chinese Taipei is temporarily suspended for a period of 90 days since 13 November 2022 onward in the Thai Royal Gazette. Except the feathers and down of poultry that have been processed in the approved establishment by the DLD and these commodities that have been processed to ensure the destruction of avian influenza virus recommended by OIE Terrestrial Animal Health Code topics 10.4.22 and 10.4.23 which use one of the following methods:

- washed and steam-dried at 100°C for 30 minutes;
- fumigation with formalin (10% formaldehyde) for 8 hours;
- irradiation with a dose of 20 kilogray.

The day-old poultry and fertilized eggs

The draft amendments of Article 4, Article 22 and Article 5 (Attachments 1-2, 1-3, 2-2 and 2-3) of the "Regulations for the Importation of Objects Subject to Animal Quarantine".

1. Considering the epidemic of highly pathogenic avian influenza (HPAI) occurring in major poultry production countries, the draft amendments provide alternatives to import the day-old poultry and fertilized eggs from the designated establishments. The risk assessment for the designated establishments must be conducted and approved by our central competent authority to ensure the designated establishments which are able to prevent the infectious animal diseases from introducing to our territory. 2. The exporting country must take action to comply with the related requirements for the mentioned designated establishments. 3. Amended the abbreviation of the World Organisation for Animal Health from "OIE" to "WOAH".

Live poultry (HS code: 0105), day-old chicks (HS code: 0105.11), hatching eggs, and poultry products including poultry meat (HS code: 0207) except heat-treated products

United Arab Emirates is imposing a temporary ban on the importation of domestic and wild birds and their untreated by-products from Ecuador.

Following the notification published by the World Organization for Animal Health regarding the outbreak of Highly Pathogenic Avian Influenza Virus (HPAI) in Ecuador, the United Arab Emirates is applying a precautionary sanitary measure to prevent the risk of introducing HPAI virus through the imports of live birds and their products from Ecuador.

These measures include:

1. Temporary ban on the importation of domestic and wild birds and their untreated poultry product and by-products and day-old chicks and hatching eggs from Ecuador to the United Arab Emirates;
2. Continue to allow the importation of heat-treated poultry products and by-products from Ecuador;
3. Continue to allow the entry of consignments of unheat-treated table eggs according to the health certificate approved between the two countries.
