Por otro lado, el SAG seguirá verificando in situ y autorizando aquellas cámaras de tratamiento cuarentenario que ingresan por primera vez o que hayan dejado de trabajar por una temporada o más, perdiendo continuidad y se encomendará al ICA las inspecciones anuales sucesivas. Finalmente, para la renovación de habilitación de aquellas cámaras autorizadas por el SAG y que no han perdido continuidad, ICA deberá enviar a SAG, para su análisis, informes técnicos oficiales con los antecedentes indicados en la resolución adjunta, los que serán evaluados antes de decidir la pertinencia o no, de otorgar la autorización respectiva. Proposals to Amend the New Zealand (Maximum Residue Levels for Agricultural Compounds) Food Notice G/SPS/N/NZL/677 The document contains technical details on proposals to amend the current Notice issued under the Food Act 2014 that lists the maximum residue levels (MRLs) for agricultural compounds in New Zealand. MPI proposes the following amendments to the Notice: The amendment of existing entries in Schedule 1, Maximum Residue Levels for Agricultural Compounds, for the following compounds and commodities: Chloramphenicol, to update the MRL for "any food" from 0.0003(*) mg/kg to 0.00015(*) mg/kg. Febantel, to update the MRLs to 0.05 mg/kg in mammalian fat, 0.05 mg/kg in mammalian kidney, 0.5 mg/kg in mammalian liver, and 0.05 mg/kg in mammalian meat. Mefentrifluconazole, to set MRLs at 0.07 mg/kg in grapes and 0.01(*) mg/kg in pome fruits. Methomyl, to remove the MRL for pome fruits. (*) indicates that the maximum residue level has been set at or about the limit of analytical quantification. The removal of existing entries in Schedule 1, Maximum Residue Levels for Agricultural Compounds, for azaconazole, fenarimol, fenbuconazole, and tolylfluanid. The addition of new entries in Schedule 3, for Veterinary Medicines for Which No Maximum Residue Level Applies, for the following compounds: Adenosine and its 5'-mono-, 5'-di-, and 5'-triphosphates, when used as a vasodilator in animals. Performic acid, when used as a teat sanitiser on dairy cattle.

The DLD order on temporary suspension of importation of live poultry and poultry carcasses from India to prevent the spread of Highly Pathogenic Avian Influenza (H5N8 and H5N1)
G/SPS/N/THA/468 According to the announcement of the Government Gazette dated 9 September 2021, the suspension for importation of live poultry and poultry carcasses from India has expired on 7 December 2021. However, The OIE reported, Highly Pathogenic Avian Influenza (HPAI) in area of India. Therefore, it is necessary for Thailand to prevent the entry of Highly Pathogenic Avian Influenza (HPAI) disease into the country. By the virtue of Animal Epidemics Act B.E. 2558 (2015), the importation of live poultry and poultry carcasses from India is temporarily suspended for a period of 90 days since 8 December 2021 onward in the Thai Royal Gazette.
