The changes in the Annexes to the Directive relate to: the establishment of maximum levels for nickel, Δ9-tetrahydrocannabinol (Δ9-THC) and p-phenetidine; certain maximum levels for arsenic, cadmium, lead, rye ergot, endosulfan, heptachlor, hexachlorobenzene, hexachlorocyclohexane, dioxins and dioxin-like PCBs, Datura seeds; the section on authorised feed additives in feed for non-target animal species following unavoidable carry-over following changes in the conditions of authorisation of certain feed additives; certain action levels for dioxins and PCBs.</p>	16/02/2025

Certain categories of animals and goods for human consumption

Commission Implementing Regulation (EU) 2023/2744 of 20 November 2023 amending Implementing Regulation (EU) 2020/2235 as regards model animal health certificates, model official certificates, model animal health/official certificates and private attestation, for the entry into the Union or transit through the Union of consignments of certain categories of animals and goods, and official certification regarding such certificates (Text with EEA relevance)

The Regulation amends notes for the completion of model certificates for the entry into the Union of animals, products of animal origin, composite products, germinal products, animal by-products, sprouts for human consumption and seeds intended for the production of sprouts for human consumption and model certificates for the entry into the Union of consignments of certain animals and goods intended for human consumption to, i.e.: reflect new Union animal health requirements introduced to Commission Delegated Regulation (EU) 2020/692 by Delegated Regulation (EU) 2023/119; update references to new Union legislation regarding residues and public health requirements for the entry into the Union of products of animal origin and goods for human consumption, simplify and harmonise certain descriptive elements relating to the establishments from which consignments are dispatched or in which they are obtained or prepared; align and clarify BSE attestations; and clarify and make consistent the wording of certain requirements, notes and footnotes.

It describes health conditions that affect trade and use of embryos of live bovine animals, collections, transport, processing and storage of bovine embryos and the model of veterinary health certificate of bovine embryos.

This regulation lays down the animal health conditions for imports of certain birds into Albania, from other countries and parts thereof referred to in Annex I of this regulation, and the quarantine conditions for such imports. It describes approval of establishments keeping such birds, import conditions, quarantine centers', transport of birds, monitoring of transport of birds, quarantine measures, examination, samples and tests carried out for such birds, measures taken in case of suspicion of any disease, measures taken in positive cases of any disease and the model of import veterinary health certificate for birds.

Mepanipyrim (pesticide active substance)
Draft Commission Implementing Regulation concerning the non-renewal of the approval of the active substance mepanipyrim, in accordance with Regulation (EC) No 1107/2009 of the European Parliament and of the Council, and amending Commission Implementing Regulation (EU) No 540/2011 (Text with EEA relevance)

This draft Commission Implementing Regulation provides that the approval of the active substance mepanipyrim is not renewed in accordance with Regulation (EC) No 1107/2009. EU member States shall withdraw authorizations for plant protection products containing mepanipyrim as an active substance. The non-renewal of approval is based on the first evaluation of the substance for use as a pesticide active substance in the EU under Regulation (EC) No 1107/2009. The substance was formerly assessed and approved under Directive 91/414/ EEC. This decision only concerns the placing on the market of this substance and plant protection products containing it. Following non-approval and the expiry of all grace periods for stocks of products containing this substance, separate action may be taken on MRLs and a separate notification will be made in accordance with SPS procedures. This draft Commission Implementing Regulation was also notified under the TBT Agreement in notice G/TBT/N/EU/1040.

Currently, SFA subjects all GE crops to SFA's pre-market safety assessment and approval for genetically modified (GM) food. Following a review of the regulatory framework, developers can submit information to notify SFA on GE crops that are equivalent to conventionally bred crops, and be exempted from the GMO pre-market safety assessment.

This draft Commission Implementing Regulation provides that the approval of the active substance dimethomorph is not renewed in accordance with Regulation (EC) No. 1107/2009. EU Member States shall withdraw authorisations for plant protection products containing dimethomorph as an active substance. The non-renewal of approval is based on the first evaluation of the substance for use as a pesticide active substance in the EU under Regulation (EC) No. 1107/2009. The substance was formerly assessed and approved under Directive 91/414/ EEC. This decision only concerns the placing on the market of this substance and plant protection products containing it. Following non-approval and the expiry of all grace periods for stocks of products containing this substance, separate action may be taken on MRLs and a separate notification will be made in accordance with SPS procedures. This draft Commission Implementing Regulation was also notified under the TBT Agreement in notice G/TBT/N/EU/1038.

Feed additive products

Notice of authorisation of thirteen feed additives

The UK Food Safety Authorities are notifying Members of the intention to authorise thirteen feed additives products for use in the GB market, consisting of new authorisations, modifications and renewal of existing authorisations (with changes either to the conditions of use, label requirements, formulation and/or for use with different animal species or their sub-groups). Applications were submitted and have been examined by the FSA and FSS under the UK risk analysis process. These authorisations are made on the basis of the feed additive functions set out below, with detailed specifications set out in the consultations linked in section 9. Nutritional additives, belonging to the functional group of 'amino acids, their salts and analogues' intended to provide essential micro-nutrients to animal diets: RP1052a - L-lysine base (liquid) (new authorisation) as a feed additive for all animal species; RP1052b - L-lysine monohydrochloride (new authorisation) as a feed additive for all animal species. Technological additives, belonging to the functional group of 'silage additives' intended to improve the production, fermentation or and/or aerobic stability of silage in the preparation of animal feed: RP263 - *Lacticaseibacillus rhamnosus* (IMI 507023) (new authorisation) as a feed additive for all animal species; RP267 - *Pediococcus pentosaceus* (IMI 507024) (new authorisation) as a feed additive for all animal species; RP270 - *Pediococcus pentosaceus* (IMI 507025) (new authorisation) as a feed additive for all animal species; RP271 - *Lactiplantibacillus plantarum* (IMI 507026) (new authorisation) as a feed additive for all animal species; RP272 - *Lactiplantibacillus plantarum* (IMI 507027) (new authorisation) as a feed additive for all animal species; RP273 - *Lactiplantibacillus plantarum* (IMI 507028) (new authorisation) as a feed additive for all animal species; RP687 - *Lactiplantibacillus plantarum* (DSM 26571) (new authorisation) as a feed additive for all animal species. Zootechnical additives, belonging to the functional group of 'digestibility enhancers' intended to improve the digestibility of animal diets: RP215 - Endo-1,4-beta-xylanase (3.2.1.8) (renewal and new use) as a digestibility enhancer for all poultry species, piglets (suckling and weaned), pigs for fattening and minor porcine species; RP954 - Endo-1,4-beta-xylanase (3.2.1.8) (renewal) as a feed additive for piglets (weaned), chickens for fattening, chickens reared for laying, turkeys for fattening and turkeys reared for breeding; RP955 - 6-phytase (EC 3.1.3.26) (renewal) as a feed additive for poultry for fattening, poultry for breeding, poultry for laying and pigs. Zootechnical additive, belonging to the functional group of 'substances which favourably affect the environment' intended to reduce the production of methane emissions: RP1059 - 3-nitrooxypropanol (new authorisation) as a feed additive for ruminants for milk production and for reproduction.

Amendments to Commission Implementing Regulation (EU) 2019/2072

The following amendments are being made to England, Scotland and Wales (Great Britain) retained legislation (Commission Implementing Regulation (EU) 2019/2072): A. The addition of new GB Quarantine Pests (QPs) which have been assessed as meeting the criteria to be a QP: Chrysobothris femorata – with specific import requirements on host plants and wood from Canada and the United States; Chrysobothris mali – with specific import requirements on host plants and wood from Canada and the United States; Chilli veinal mottle virus – no specific import requirements; Lycorma delicatula – no specific import requirements. B. The addition of new GB Provisional Quarantine Pests (PQPs) which have been assessed as meeting the criteria to be a QP based on a provisional assessment: Agrilus mali; Lonsdalea populi; Orgyia leucostigma. C. The addition of Solanum sisymbriifolium seed as a new known host to the existing Regulated Non-Quarantine Pest (RNQP) Potato spindle tuber viroid (PSTVd), as the pest-host combination has been assessed as meeting the criteria of a RNQP. D. Providing a specific import requirement for the introduction of spruce (Picea spp.) Christmas trees, not intended to be placed on the market, from Norway for short term display only.
